In response to Commissioner Alfred Ambrosini's erroneous comments in today's Herald Standard, am requesting a "Hearing" of the Fayette County Election Board. This is clarification of what I am requesting.

- 1. First, Commissioner Ambrosini does not have the sole authority to deny a citizen a "Hearing" There are three election board members, all with equal authority. He again is not a dictator as much as he may like to be. I am asking that all three members step aside and allow this hearing to proceed.
- 2. I want this "Hearing" to investigate this current Election Board's violations of the "State Election Code". Any reasonably intelligent person would understand that this board can't investigate its own actions. These clear conflicts of interest dictate that an independent election board is selected by and independent judge since it has clearly been established that our Fayette County Court of Common Pleas has a clear conflict of interest in this matter.
- 3. This present Election board is respectfully being asked for a full recusal from this hearing for the above stated reasons. This is also the same request of the Fayette County Court of Common pleas.
- 4. I want this hearing to investigate the "violations and irregularities" of the Pennsylvania State Election Code, by this Election board and its Solicitor, Sheryl Heid. As such, Sheryl Heid should be a party to these proceeding as she may be called as a witness as well.
- 5. The current District Attorney, Jack Heneks, has a conflict of interest as well. He is on record as a supporter of the plan to build this prison. As such, I ask that the findings of this independently appointed election be turned over to the State Attorney General and or the United States Attorney for possible prosecution of the election code violations and irregularities.

I am doing so in response to this board's illegal action taken on 4-22-2014, A hearing is required to present testimony and case law as to this board's purposeful and willful violations of the election code, and this board's very own resolutions unanimously passed in 2012. The independently selected new Election Board will have "Quasi Judicial Authority" to subpoena witnesses, hire investigators, and take recorded testimony and depositions if needed. My standing in this matter is the fact that I am an affected signer to this petition, an enrolled registered voter, and citizen of Fayette County.

The conflicts of interest and the very nature of my complaint now dictate that this board be replaced by a fair and impartial election board to hear the testimony; and render a fair decision as to the violated process by the present election board. Additionally, the current Court of Common Pleas needs a complete recusal based on the court having a conflict of interest in any of these proceeding. The President Judge, John Wagner has already penned a letter stating the "Fayette County Court of Common Pleas is supportive of the Commissioners initiating the process to construct a new prison." This disqualifies the entire bench from being fair and impartial in this matter. I respectfully request that an outside Judge be appointed in the matter so that judge can take charge of these proceedings and immediately appoint a new election board to hear this most important issue.

Again, this is an issue of paramount importance and any delay in action is disenfranchising all of the citizens of Fayette County's "Due Process Rights" to address this election board's violations and irregularities of the State Election Code. When the election code is violated in such an egregious manner; our whole system of government falls under suspicion. I appreciate your immediate attention to this matter.
